

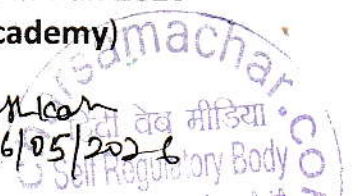

With due respect , this is to inform you that the Self Regulatory Body of the Web Media Outlet "www.navsancharsamachar.com "(referred to as "Web Media: navsancharsamachar.com" in subsequent sections) was previously constituted on 10 NOV 2022.

As per the Government guideline, a provision was established to nominate a retired judge as the Chairperson of the Self –Regulatory Body for web Media. However, in compliance with the government order, due to the non –availability of a retired judge at that time, Dr. M.K . Srivastava --- a renowned and learned advocate from Samastipur – was nominated as the Chairperson, and the details of the newly formed body were submitted to you.

It is with deep regret that we now inform you that the current Chairperson, Dr. M.K. Srivastava, passed away on March 3, 2026 consequently, the position of Chairperson has fallen vacant.
